NINJA COURSE WAIVER RELEASE AND INDEMNITY

NINJA COURSE WAIVER RELEASE AND INDEMNITY

I further agree to indemnify and hold harmless Fitset Ninja and the Released Parties from liability for the injury or death of any person(s) and damage to property that may result from my negligent or intentional acts or omission while participating in activities offered by Fitset Ninja.

- The waiver must be signed before dropping in.
- Wristbands must be worn for access.
- Children 12 and under require parental supervision.
- Clean indoor shoes or sock feet only. No outdoor shoes.
- Do not climb on top of Warp Walls or the rigs.
- One person at a time on each obstacle.
- No running around or through the course.
- Do not move any obstacles.
- No food or drinks in the rink and obstacle areas.
- Guests may be limited to 1 hour depending on availability.
- Staff reserve the right to stop any person if they do not abide by these rules.
